**PARENTAL AGREEMENT**

1. I understand the importance of and assume responsibility for notifying Kid's World Learning Center of any significant changes in enrollment information such as work and phone numbers, emergency contacts, authorized pick-up persons, medical information, etc.
2. I understand an annual, non-refundable registration fee of \$ \_\_\_\_\_ is due and payable upon enrollment and will be due and payable every year thereafter on the anniversary date.
3. I agree to pay the total weekly fee of \$ \_\_\_\_\_ on Friday for the upcoming week. I further understand that a late fee of \$15.00 will be assessed if tuition is not paid by Tuesday for the current week's service. An additional \$15.00 late fee will be assessed if tuition is not paid by Thursday evening. Failure to stay current in my child's tuition may result in loss of my child's space at Kid's World Learning Center and will constitute a default which will entitle Kid's World Learning Center to all remedies as prescribed by law including reasonable attorney's fees.
4. I agree that if my child is absent one week or more, I may pay one-half of the regular weekly tuition as a holding fee. I understand my child's enrollment may be discontinued if this fee is not paid in advance. Any attendance during any given week constitutes a full week and payment is due in kind.
5. I agree to provide the center with all necessary information pertaining to administering medicine to my child.
6. I understand my child will be provided with all snacks and lunch served daily during their hours of attendance.
7. I understand that according to the center's regulations, it is my responsibility to escort and log my child in and out of the center.
8. If my child wears diapers, I understand I will provide whatever disposable diapers are necessary as well as baby wipes for my child. I understand only *disposable* diapers are permitted in the center.
9. I understand I am totally responsible for any special diet required by my child. If my child's diet consists of formula/ breast milk taken from a bottle, I understand I will provide Kid's World Learning Center with the appropriate number of bottles containing ready-to-feed milk, necessary for my child each day. Each bottle will be clearly labeled with my child's first and last name.
10. I understand that if my child is ill, including but not limited to, a severe cough or sore throat; undetermined rash or spots; temperature over 100.4 degrees; severe headaches, upset stomach or diarrhea, he/she cannot be accepted into the center until well. In the event my child has a communicable disease, a release form from a medical source may be required before my child re-enters the center. Kid's World Learning Center will notify parents if a communicable disease has been introduced into the center.
